




## Member Instructions for Managing Court Bookings with Skedda

FFTC Skedda accounts will be created for all members in early May. You will receive an email invite to complete your registration and create your password. Only registered FFTC members can login and view our online calendar.

You may [login to Skedda](#) on your browser, or with the mobile apps for [iOS](#) and [Android](#).

You can search bookings by Day, Month, Grid or List view. Pointing to, and hovering over, any booking will display additional booking details including the convenor name, email and phone number. In Day view, you can select an available window and court and double click to create a new booking. Alternatively, in the Day, Month, Grid or List view, you can click the large  at the bottom right of the screen to create a new booking.

## Booking Rules (Convenors and Pros are exempt from these rules)

- No recurring bookings
- Each booking is limited to a maximum of 2 hours (in 30-minute intervals)
- Maximum of 5 future bookings at any given time per member
- Cannot make a booking more than 14 days ahead
- Players who have booked a court for a specific time take precedence over players who are “walk-ons” for that particular court. If you have not booked a court, you may be asked to give up your court by players who have made a Skedda court booking.
- Special considerations when booking court 4:
  - Court 4 is available for members to book but please take note that it is also a Pro court. The court is equipped with a curtain that is closed during lessons to lessen the disruption to adjacent courts with errant balls. Our Pros will not book a lesson when all four courts are booked by members. However, should a lesson be requested of them and court 4 has been booked by a member while there are other open courts, the Pro reserves the right to ask the member(s) on court 4 to move to another open court.
